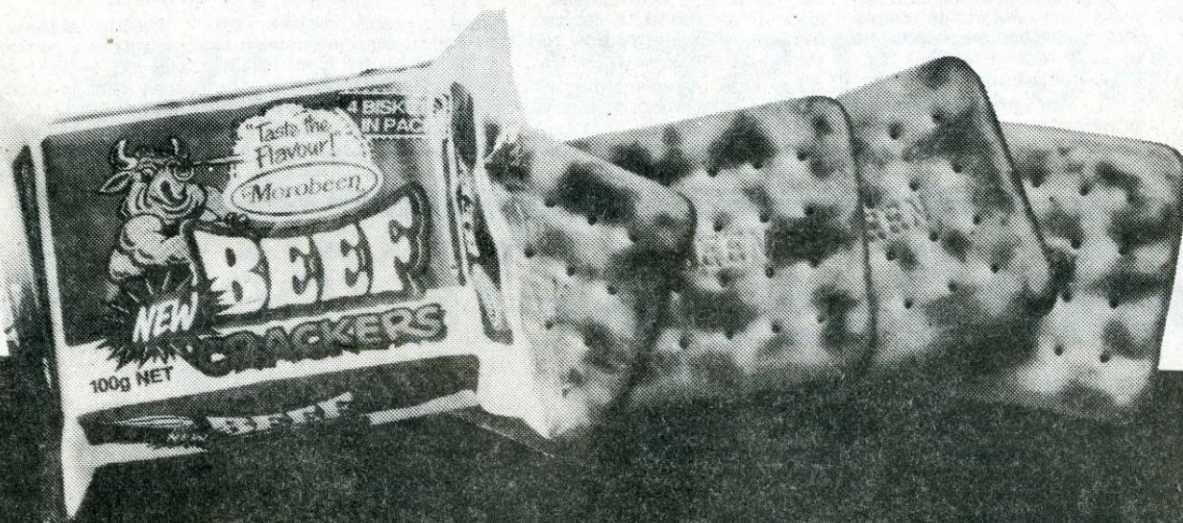

21 May 1989: Bomb blast at Panguna Bus Depot.

22 May 1989: Shooting at BCL bus at Pakia Gap.

22 May 1989: Arson to BCI Pylon No.58 Pakia.

23 May 1989: Arson to Kumo crusher by explosive.

24 May 1989: Shooting of policemen at standby generator, Panguna.

24 May 1989: Attempt to blow power pylon at Biremba.

25 May 1989: Attempt to burn down Jaba Pump Station, Panguna.

25 May 1989: Shooting of SHRM vehicle at Pakia.

26 May 1989: Bomb threats at Defence vehicle.

26 May 1989: Wounding of CID member at Policeman's Corner by shot gun.

28 May 1989: Shooting at Tanuru Junction by militants with shotgun.

30 May 1989: Wounding of Severinus AMPOAI's son at Pakia village and damage to his 15-seater bus.

1 June 1989: Threatening letter to William BAINDU, BCL employee.

6 June 1989: Murder of two children at Nambis Camp.

6 June 1989: Shooting at policemen near Provincial Government Building.

7 June 1989: Shooting at Section 4 Arawa.

8 June 1989: Arson to Jaba Pump Station.

8 June 1989: Shooting at Mr Greg BOSCHAT, Section 12 Arawa.

9 June 1989: Threats to blow Lime Stone Magazine.

12 June 1989: Damage to BCL by vehicle shotgun pellets at Pakia village; driven by Mr George Kriticos.

12 June 1989: Damage to BCL vehicle by shotgun pellets, Jaba.

12 June 1989: Shooting at Mr Geoff R. RASON with .22 rifle, Jaba.

24 June 1989: Att/murder of one Isaac KAMENG by shot-gun.

24 June 1989: Arson to Severinus AMPOAI D/house at Piva village.

24 June 1989: Threat call to blow up Arawa Police Station.

25 June 1989: Arson to power generator at Mananau.

26 June 1989: Threatening with actual violence by suspects militants from Kieta.

26 June 1989: Shooting at Pakia by M16 by militant.

1 July 1989: Det F. CONOT was shot at with pellets to his right arm; treated and discharged at Panguna Medical Centre.

1 July 1989: Constable 9962 TODE shot with pellets to his chest. No internal damage. Shooting took place at Finger Point, Panguna Road. Member treated and discharged.

2 July 1989: 1. Const.7820 BAUBA, 2. F/Const. 7818 KAGENT were shot at. Const. BAUBA was shot and pellets went into his nose and pellets went into his both eyes. Const. KAGENT was shot in the back with pellets to his right shoulder blade. Both admitted to Arawa, in stable condition.

3 July 1989: Three members were shot and wounded.

1. S.Const. MEMEPE received pellet to his left side of his head. He was treated and discharged at MFC, Arawa.

2. Const. AIPA shot and received pellets to his left side of his chin and right middle finger. His condition was stable at (MFC).

3. Const. KAUBA shot in his right thigh. He is under operation and stable.

Members were returning from Panguna when shot at Pangiba village where stronghold of militants currently operated.

3 July 1989: Wilful Murder: National male Jori Ambros VESOME, 45 years, of Onemuka village, Kainantu, Eastern Highlands Province. Married to a woman from Memau village Jaba Road. Was attacked by 60 militants and shot with six arrows in the back. His body was chopped and he died. He was found in the bush by brother, Vesome. Incident occurred on July 2, about 1400 hrs. No suspects arrest.
